MACV's Background



- In September of 2010 Mayor Gregory Ballard appointed Russ Eaglin to be the cities first full time Veterans Services Officer. He left in 2013.
 - MACV had its first meeting in January of 2011.
 - August 6th 2011 was our 1st Mayor's Veterans Appreciation Day event
 - October 15th 2016 was our 6th Mayors' Veterans & Family Appreciation Day event
 - MACV's initial purpose was then, as it is today, was to:
 Build a stronger Coalition of service providers to better support
 our Veterans by working across organizational lines, coordinating
 resources, to help solve common Veteran issues.
- In February 2016 Mayor Joseph Hogsett directed MACV to continue its networking and to find more ways to help Veterans.
 - In June of 2016 Mayor Hogsett appointed Matt Hall to be the cities new Veterans Service Officer.





MACV & VSCMC

(A Public-Private Partnership)



- MACV is a Public (City of Indianapolis) Program that <u>Advises</u> the Mayor, or Mayors' on Veterans needs, services and programs.
 - Usually does not raise funds for programs/events, other than in-kind products or services.
- VSCMC is a Private, Non-Political, Non-Profit Indiana Corporation that <u>Supports</u> MACV and Marion County Veterans.
 - Responsible for helping raise funds for Veterans events, including but not limited to, the Mayors' Veterans & Family Appreciation Day event.
 - VSCMC was formed on the 6th of March 2014 and received its 501 (c)(3) public charity status on the 28th of January 2016.
 - VSCMC meets the 3rd Tuesday of each month at the Marriott-East at 2:00 PM, just before the MACV meeting.

Mayors' and Town Managers of Marion County on issues that affect the Veterans in our community;










MACV's Mission & Goals

MACV's Networking Program



MACV's networking program now consists of getting together and documenting all types of organizations that are currently working with, or are willing to work with, our Veterans in Marion County, ensuring that they are receiving the benefits and services to which they are entitled, then sharing that information with Veterans who need it, thru; Service Providers, Outreach & Web Sites, etc.







MACV's Guidelines for Membership



Everyone is always welcome to attend any MACV meeting or Subcommittee meeting.

To be considered a MACV Member or MACV Associate you must do one of the following:

- 1) MACV Member (Voting Member) Attend at least nine (9) monthly meetings per 12 months
- 2) MACV Associate (Non-Voting Member) Attend at least four (4) monthly meetings per 12 months
- 3) Visiting individuals and Organizations (Non-Voting) are welcome to make presentations at MACV meetings on how they are, or can help our veterans (Should be approved in advance by the Leadership Committee)

MACV always meets the third Tuesday of each month at the Marriott-East (21st & N. Shadeland Ave.) from 3:00 to 4:30 PM

- The Leadership Committee is responsible for:

SubCommittee Guidelines



Suggestions:

- 1) The number of subcommittee members is not fixed but should consist of from 5 to 15 MACV Members and/or MACV Associates;
- 2) All subcommittee members do not have to be MACV Members;
- 3) The Chair, Vice-Chair and Secretary must all be MACV Members;
- 4) The Executive Committee, with input from the Mayors' and Town Manager will suggest an agenda for each Subcommittee;
- 5) Subcommittees choose their own; chair, co-chair, secretary, date, time and place to meet;
- 6) Subcommittees set their own goals and timetables;
- 7) Subcommittees can request visitors to speak at their meetings;
- 8) All subcommittees should meet at least one time per month before each MACV meeting;
- 9) All subcommittees are required to give an update of their findings and/or progress to the monthly MACV meeting so the Leadership Committee can compile a monthly report to deliver to the Mayors'.

Suggestions:

- 1) First and foremost, we didn't want to start another committee just for the sake of having another committee. We wanted these subcommittees to be working committees that actually accomplishes something;
- 2) Subcommittees can and should work with other organizations that have similar subcommittees working on similar topics Example: CHIP on their CoC homeless and veterans subcommittees);
- 3) Subcommittees should first identify organizations that offer services and benefits within its assigned topics;
 - We want to make sure that information is shared and added to our web site.
- 4) Subcommittees should focus on ensuring that all Veterans are made aware of everything to which they're entitled (services & benefits), and how they can access it.
